The meeting for the above mentioned paper organised by the Department of Commerce, University of Delhi was held on Google Meet platform (hosted by PGDAV College) on September 2, 2020 at 02:00 PM. The following guidelines were set in the meeting with the consent of all teachers and the representative from Department of Commerce, University of Delhi:

- 1) In Unit-I, NCLT, NCLAT and Special Courts to be discussed in the context of their constitution and functions while in Unit-V, in the context of dealing with Winding Up. Government Company, Holding and Subsidiary Company are also to be discussed. In Producer Company only meaning, objects, who can form and difference between Producer Company and Private Company is to be covered.
- 2) In Unit-II, Doctrine of Ultra Vires, Deemed Prospectus, Abridged Prospectus are to be included. In Demat System; meaning, advantages and transfer of shares under Demat System shall be discussed.
- 3) In Unit-V relevant provisions of Insolvency & Bankruptcy Code (IBC) shall be limited to -
 - a) Meaning of Corporate Applicant, Financial Creditor, Operational Creditor and Step wise Insolvency Resolution Process in brief with situations when liquidation order is passed.
 - b) Sec. 59 of the Code i.e. Voluntary Liquidation of the Company.
