

#### General Points:

1. The Faculty members are encouraged to refer to various government websites.
2. Appropriate examples are also to be discussed to elaborate on the various concepts.
3. The syllabus should be strictly adhered to.
4. The paper setting board should frame the Question Paper and Marking Scheme in such a manner that objectivity during evaluation can be maintained.
5. Question Paper should be strictly set according to the guidelines.

#### Examination-Related Guidelines:

1. Total number of lectures assigned as per UGC Norms is 45 and the marks for the theory examination are 90 Marks.
2. The First Four questions, numbered one to four, will follow an internal choice format. These questions must comprehensively address the entire syllabus and should not contain more than two parts each. Question Number 5 will be of 18 marks based on short notes in the format of attempting any three out of 5 (i.e., 6 marks each) covering all units.


